Information for International Applicants from countries outside the European Union

Please read the following information for international applicants carefully and ensure that you complete and compile your application accordingly.

(Applicants with non-EU citizenship but German university entrance qualification (e. g. Fachhochschulreife oder Abitur) are treated as German applicants and apply accordingly.)

General

Put simply, you are only able to study at a German university if your qualifications would allow you to study the same subject in your home country, too. Due to different educational systems, qualifications from different countries are not always comparable. Thus it is possible that an applicant, in addition to their home qualification, has to complete the Studienkolleg here in Germany (two semesters) or is required to submit proof of 1-2 years of successful studies at a university in their home country. In order to apply for a study place, you have to observe the following steps:

1st step: Conversion of Grades at Studienkolleg Konstanz (centre for international students)

In order to study at any university within the German federal state of Baden-Württemberg, all international applicants with international qualifications are required to submit their qualifications at the Studienkolleg Konstanz for evaluation and certification. The Studienkolleg Konstanz assesses whether or not a qualification fulfils the German requirements for university entry and determines the equivalent average grade under the German system.

Please ensure that you send your documents first to:

You can find detailed information on the requirements at https://www.htwg-konstanz.de/en/studying/center-for-international-students/start-page/. Please ensure that you submit the following documents:

- school-leaving certificates from your home country (GCE-A-level, Baccalaureat, Matura, High School Diploma, etc.) an officially certified copy of the original as well as a German translation; if the document is originally in English or French, no translation is required
- list of subjects and grades (certified copy of the original and German / English translation)
- CV / resume including complete educational history

where applicable, also include:

- evidence of modules completed at university (certified copy of the original and German / English translation)
- certificates from Studienkolleg, if you have previously attended at a German Studienkolleg (certified copy of the original)
- proof of university entrance exam (SAT, ACT, AP)

Please note: All photocopies have to be officially certified. Outside of Germany, only the German consulates and embassy are able to certify documents to the required standard). Documents submitted will not be returned!

Applicants from the PR China and Vietnam please note

You additionally have to submit the original certification of the Academic Evaluation Centres (Akademische Prüfstelle APS) at the German Embassies in Bejing https://www.aps.org.cn/ or Hanoi http://www.hanoi.diplo.de.



English language qualification

All applicants must submit evidence of their English language qualifications. This is a requirement because there are several non-native varieties of English spoken throughout the world.

Listed below are the only qualifications which can be accepted. If any other proof is submitted, the application will not be considered valid. No exceptions can be made, even if English is an official language in your home country and / or your entire education was in English.

- TOEFL (550 paper-based PBT, 79 internet-based iBT, or higher) no more than two years old
- IELTS (6,0 or higher) no more than two years old
- Cambridge Certificate of Proficiency (grade B or higher)
- Cambridge Advanced Certificate (grade A)
- English grade from a secondary school in the European Union
- GCSE in English (grade B or higher)
- International GCSE in English as a second language (grade B or higher)

Exempted countries

Citizens of one of these countries do not have to submit proof of English language proficiency. All other applicants must do so!

Australia, Canada, Ireland, New Zealand, United Kingdom, United States of America

2nd step: online application on mio.hs-furtwangen.de

Please save the following documents, which you will need for your online application, as PDF files on your PC:

(You can upload one PDF for one category. If you have more than one proof for one category, please save the pages in one PDF)

- university entrance qualification: certificate from "Center for International Students", Konstanz in one PDF with your school certificate and academic transcripts in original language and German or English translation
- Curriculum Vitae
- Proof of English language proficiency
- Orientation test results (www.was-studiere-ich.de). Please contact the admissions' office for an English version of the test.
- if you have previously studied at a university in Germany: confirmation of deregistration
- Register on the Furtwangen University application portal at https://mio.hs-furtwangen.de As confirmation you will receive a welcome email with an activation code.
- Apply to our university. Please select: "International Business Management non-EU Version". You will be guided through the application
 process by an assistant.
- You can interrupt the application process at any time and resume it later, e.g. if you need to research information. Your previous information will be retained.
- You can only edit the application and the relevant information until the point where you finally submit it by clicking on "Submit
 application". After that, changes can only be made after the application has been withdrawn and the application will not be processed by
 the university until it is resubmitted. You can use the "Print Control Sheet" function to check and print all of your entered data.

What happens next?

At the end of the application deadline the selection process will take place. Applicants will be ranked according to the average grade of the university entrance qualification. The successful applicants will receive an admission offer in late June to allow sufficient time for the visa application. You can accept the study place online. Afterwards the admission letter will be available for download on the online application portal.

At the same time, you will receive an email with the fee notification and enrollment information.

Application deadline for the winter semester:

Studienkolleg Konstanz: You can apply for certificate recognition at any time. Processing time: several weeks.
